How Do We Manage Child Custody and Child Support?

If you have children, protecting them during divorce is important to you, and you already know that children often feel torn between parents. ***We focus on the best interest of the children regardless of the costs.*** We encourage parents to strongly consider children's when it comes to having relationships with both parents.

How Does a Divorce in Salt Lake City Work?

You'll begin by preparing a petition of divorce and necessary paperwork, which we'll help you complete. Your spouse, who is referred to as the respondent, will then be served and must respond within 20 days. In the case of failure to respond, a court may award a default judgment. However, if the respondent agrees to your terms, you may have an uncontested divorce.

If the respondent disagrees with your terms, they may contest it, in which case a trial will be scheduled. ***The court requires that parties attend mediation to try to work things out in order to avoid trial.*** At this point, the case may be resolved, or the spouses may reach an out-of-court agreement. 90-days after the petition a judge can sign the final decree or it goes to court where you'll each be able to make your case. ***If you have children, the Utah law requires both of you to attend a divorce education class.***
