

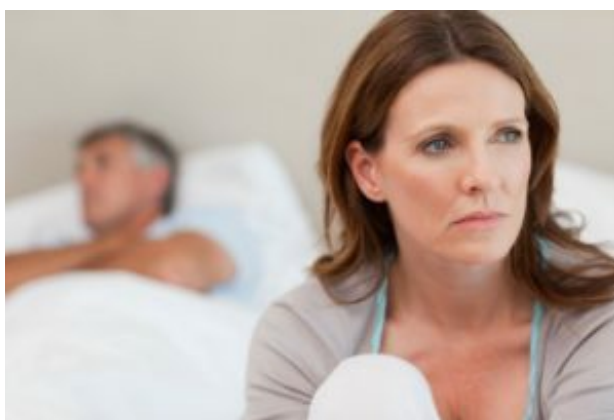
Domestic Violence and Divorce Attorney in Utah

coercive control of resources. In 2016, a report on the divorce rate in the United States in 2016, by state conducted by statistics indicated that Utah was ranked

14th with an estimated divorce rate of 3.6 per 1,000 population. Most of the recorded divorce cases by the state revealed that domestic violence as a primary cause of separation; however, 65% of all the aforementioned separation incidences highlighted a form of harassment even during the time of separation. Divorce in itself may be a triggering factor for domestic violence as one party infers operation to abandonment. In fact, in **most cases of domestic violence divorce reported in the state of Utah issues regarding abuse are augmented at the time when an individual decides to leave a potent relationship.**
