The first thing to understand about <u>divorce in Utah</u> is that this is a no-fault state. That means only one party needs to initiate the proceedings and doesn't have to provide an official reason for seeking a divorce. Both will sign a statement that the marriage has broken down beyond repair when completing the divorce paperwork. Your attorney can assist you with preparing the divorce filing if you're the petitioner or respond to it if you receive a divorce complaint from your spouse.

One party must have been a resident of Utah and the county where he or she petitioned for or responded to the divorce complaint for at least 90 days. Utah also imposes a 90-day wait until a court hearing regarding the divorce decree takes place.
